Brad Barrett (Chair) called the meeting to order at 5:00pm

Library:

- Robin Wilson appeared before the board asking the selectboard to approve the request of a Blink surveillance camera to be installed on the outside of the library with a couple of “under surveillance signs.”
- Discussion on the ramifications of recording individuals entering the library.

Motion by Jim Pritchard, second by Daryl Burlett for approval for the library to install a Blink camera on the exterior of the library including a couple of surveillance signs, motion carried.

Highway Department

Road Foreman Report

1. Finishing Lake Rd project that included ditching and gravel
2. Fish and Wildlife would like a beaver baffle installed in Cranberry swamp pond
3. Little truck is close to being repaired in the meantime using the MAC to apply chloride
4. Roadside mower had a lift cylinder rebuilt, the West side of town has been completed once for mowing and starting on the East side.

Road Commissioner:

- Discussion the fit-up for the new truck does not have to be done under state contract, can still price it out with other vendors

Transfer Station:

- Inspection was completed and no violations were found

Fire Department:

- The State of Vermont has a new law that took effect July 1st, 2026, that mandates the Fire Chief is automatically assigned as the Forest Fire Warden.
- Fire Department's property still has not been removed from the basement of the Town Offices, there are concerns this will hold up construction. Selectboard Assistant was instructed to send a letter to the Fire Department as a final reminder to remove immediately or risk having it disposed of.

Treasurer Report/ Town Clerk

- \$2,015 returned from a property that withdrew from current use
- State portion of Property Tax rebates have been received in the amount of \$27,776
- Supplied a budget status report for 2025-2026
- Next meeting financials for 2026-2027 will be available
- State tax rate for non-homestead has been set at 1.9658 and homestead at 1.5116, Current use is at \$45,219
